

Applied Technology Diploma to Associate in Applied Science or Associate in Science Program Articulation

The following Applied Technology Diploma (ATD) programs shall articulate into an Associate in Applied Science (AAS) or an Associate in Science (AS) degree under provision of Rule 6A-10.024 – Articulation between Universities, Community Colleges, and School Districts. The chart below details the minimum amount of college credit that is to be awarded towards the identified A.S. or A.A.S degree(s) when a student's completes an ATD at either a technical center or college. The transfer of the ATD to an associate degree in science or associate in applied science is guaranteed for a period of three (3) years following the date of the award of the ATD as set forth in Rule 6A-10.024.
