PROOF OF ENGLISH PROFICIENCY

English is the language of Instruction at Broward Technical Colleges. Applicants for whom English is not a first/native language must demonstrate English proficiency regardless of English language studies, academic history, residence in the United States or other English-speaking countries, or immigration status.

English proficiency may be met with the Test of English as a Foreign Language (TOEFL), the International English Language Testing System (IELTS), or Pearson Test of English Academic (PTEA).

Minimum Scores:

TOEFL: 68-91 IBT (Internet-Based Test) or 520-579 PBT (paper test score)
IELTS: 6.0 – 6.5
PTEA: 51-61

Sufficient English proficiency can be demonstrated by submitting one of the following:

- Official transcripts from an accredited U.S. college or university showing successful completion of coursework including a college-level writing course (not ESOL).
- Official records from a foreign high school or higher education institution where English is the primary language of instruction may indicate English proficiency.
- TOEFL, IELTS, or PTEA scores. **NOTE:** Scores must be no more than two (2) years old upon your application date.
- Students who have recently taken approved college assessment tests.

If you meet at least one (1) of the following requirements, you are exempt from TOEFL/ IELTS/PTEA

- Your native language is English.
- You have completed all secondary or postsecondary education in the United States, Canada, or another English-speaking country.
- You are an international or non-immigrant transfer student from a non-English speaking country who has completed an Associate of Arts or Associate of Science Degree or higher from a U.S. institution.
